#### Expanding our base



We have recently revamped our digital media offering at BASE Pimlico, adding 2 new music production stations, a new iMac, 4 new android tablets, a full PA system, studio monitors and DJing equipment to our existing array of film production, photography and recording equipment. #### Benefit Cap

The Benefit Cap threshold will be lowered this autumn in line with the government's 2015 summer statement. The Benefit Cap is the total amount of allowed benefits a household can claim and London residents will see this reduce from £26,000 to £23,000 a year. The cap will also reduce for single people from £18,200 a year to £15,410 a year.

Everyone else will see their benefits cap reduce to £20,000 a year. If you or your partner have been in employment for at least 50 weeks out of the 52 weeks before your last day of work, you will be exempt from this cap. This means if you lose your job, you have 2 weeks to start a claim before losing this exemption.

From Autumn 2016 the Government will introduce exemptions for people who claim Guardians Allowance, Carer's Allowance and the Carers' element of Universal Credit.

#### Calling young artists



The YO! London project has been inspired by the Humans of New York blog, which tells the inspirational stories of the everyday people of New York.

# THE LONG TERM PERSPECTIVE



As a world city London is always going to be a challenging place in which to provide affordable housing. So much so that it is possible to look back to when Octavia Hill was writing in the 1880's and see that even then she talked about the need for more homes. But although this is a long standing problem the current housing situation in London is seriously bad.

Prices – both for buying and renting, have been rising to levels which are simply unaffordable for large groups of people while at the same time many of the new developments in London have been sold to overseas investors. In the regulated sector Local Authorities are increasingly under pressure. They are soon to be required to sell off their "high value" homes (which might be quite a large

percentage in the areas where Octavia operates) and to charge higher levels of rents to those households with an income of over £40,000. And while neither of these provisions will apply to Octavia they will have an impact on the overall supply of homes in the areas where we operate.

With all this in mind it is a good thing that each of the mayoral candidates recognises there is a problem and that in inner London this will not be solved by the "Starter Homes" which the Government are proposing. All the candidates recognise that what we really need is far more long term, secure, affordable housing for rent but the ideas for how that is going to happen are still very thin on the ground.

From my perspective most progress would come if more was done to require a fixed percentage of affordable housing as part of every single planning consent for new homes. At the moment there is still too much flexibility for developers to negotiate exceptional settlements for individual schemes which means we get fewer affordable homes on each site than we should. It is only by building more, and resisting the temptation to sell off high value inner city homes in favour of more on the outskirts of London that we will keep the mixed communities that make London such a good place to live.

# Using new legal powers to tackle Anti-Social Behaviour

We were recently successful in obtaining a 5 year Civil Injunction with a Power of Arrest. Civil injunctions are aimed at preventing individuals from engaging in ASB and are part of new legal remedies given to Social Landlords, in the Anti-Social Behaviour, Crime and Policing Act 2014.

The case was brought against an adult household member after repeated incidents of aggressive, intimidating and threatening behaviour towards Octavia staff and nuisance behaviour affecting other residents.

After hearing the evidence for all sides, which included staff and residents attending court as witnesses, the judge granted the 5 year Civil Injunction with the Power



two dedicated Investigation Officers who lead on investigating ASB/ND & Tenancy Fraud casework. These issues can be complicated and can take up considerable time. Having two officers who are dedicated only to these issues means that anyone experiencing or involved in cases of this nature will have one contact who will specialise in managing this process and keeping them informed.
